

- 1. All interested tenders are invited to participate through sealed tender along with the earnest money of Nu. 10,000.00 (Ngultrum Ten Thousand) only in cash warrant/demand draft. The cash warrant/demand draft must address to the Dean, FNPH, Thimphu.
- 2. The successful tenderer must pay 25% of the tendered amount at the time of acceptance of tender or the next working day and the balance 75% amount within Ten (10) working days from the date of acceptance, failing which the offer will be cancelled and 25% deposit shall be forfeited.
- 3. The wining tenderer shall lift the obsolete item (s) on the last day of final payment from the FNPH campus.
- 4. The earnest money of the successful tenderer will be adjusted with the offer and the earnest money of the unsuccessful tenderers will be returned immediately after finalizing the winner.
- 5. The earnest money of the successful tenderer will be forfeited if he/she refuses to accept the tender.
- 6. Inspection of the obsolete item (s) shall be allowed strictly from 21st August, 2023 during office hours. No inspection shall be allowed thereafter. Complaints of any mismatch of the condition of the obsolete items will not be entertained later.
- 7. The tender form must be submitted to the undersigned by 31st August, 2023 at 2.30 PM and the tender will be opened at 3.00 PM on the same day at Conference Hall, FNPH.
- 8. The opening committee shall read the quoted bid amount to all the participants and hand over to the evaluation committee for evaluation. The tender will be awarded to the "Highest Quoted Bidder" after the evaluation.
